

Clarification Text for Camera Recordings

Dear Interlocutors,

As Tempo Metal Aksesuar Sanayi ve Ticaret A.Ş., we record images at the entrance-exit control points, our service buildings, building exteriors and floor corridors by means of security cameras in the service area and in order to ensure building and environmental security. The recording process of the cameras is processed and stored by our IT department and supervised by the relevant directorate. Camera recordings are kept for 1 month and then securely destroyed and the destruction process is recorded.

Your Personal Data Processed through Cameras

Your video recordings, vehicle license plates, images of the people you are with are processed through camera footage.

Purpose of Processing Your Personal Data

Pursuant to Article 5 of the Law on the Protection of Personal Data, your personal data is processed automatically for the purpose of fulfilling a legal obligation, fulfilling legal obligations, occupational health and safety legislation, due to the legitimate interest of the data controller or for different legal legal reasons, provided that the fundamental rights and freedoms of the person concerned are not harmed.

Transfer of Your Personal Data Domestically and Abroad

Personal data in the processed camera recordings may be transferred to law enforcement agencies, authorized administrative and judicial authorities, law enforcement agencies in case of legal disputes or if requested in accordance with the relevant legislation.

Rights of Data Subjects as Personal Data Controllers

Pursuant to Article 11 of Law No. 6698, data subjects have the following rights: To learn whether personal data about them is being processed, To request information if their personal data has been processed, To learn the purpose of processing personal data and whether they are used for their intended purpose, To know the third parties to whom personal data are transferred domestically or abroad, To request correction of personal data in case of incomplete or incorrect processing and to request notification of the transaction made within this scope to third parties to whom personal data is transferred. To request the deletion or destruction of personal data in the event that the reasons requiring its processing disappear, although it has been processed in accordance with the provisions of the Law and other relevant laws, and to request notification of the transaction made within this scope to third parties to whom personal data is transferred, To object to the occurrence of a result to the detriment of the person himself/herself by analyzing the processed data exclusively through automated systems and to demand the compensation of the damage in case of damage due to unlawful processing of personal data Contact with the Relevant Person Regarding the Scope of Law No. 6698 Requests for the use of the aforementioned rights can be submitted by the personal data owners through the methods specified in the legislation on the Processing and Protection of Personal Data within the Scope of Law No. 6698 by Tempo Metal Aksesuar Sanayi ve Ticaret A.Ş. on the LPPD/GDPR page at https://www.timaytempo.com/. Tempo Metal Aksesuar Sanayi ve Ticaret A.Ş. will evaluate the requests of the relevant persons and finalize them within 30 days. As a relevant person, you can make your requests regarding Law No. 6698 on our Application and Disclosure Obligation page. You can contact us from our Application and Disclosure Obligation page for all your questions and opinions regarding the use of personal data within the scope of the Law on the Exercise of the Right of Non-Acceptance and Cancellation. With the explanations we have made above, we have informed you and fulfilled our Disclosure Obligation. For the deletion, updating, anonymization, destruction or other legal requests regarding your personal data, you can send us your requests via our Application and Disclosure Obligation page or via the Personal Data Protection Law Relevant Person Application Form. As the relevant person, we will respond to you as soon as possible or within the legal period (30 days) in accordance with Law No. 6698.

Caution! Those who request camera footage for personal purposes will not be given the footage. CCTV footage can only be obtained upon a court order, a request from the prosecutor's office or a request by law enforcement officers.
